HOW TO ENJOY

ORDER

your favorite adult beverage in a Social District cup from a participating establishment - **NO OUTSIDE ALCOHOL!**

DRINK

your beverage within the designated Ada Village Social District Commons Area

DISCARD

your Social District cup when empty - **NO REFILLS!**

ENJOY

the Ada Village Social District seven days a week between 12:00 PM - 10:00 PM.

*Alcoholic beverages purchased at one establishment can be enjoyed in the establishment in which it was purchased or outdoors in the Social District Commons Area, marked by signage. Beverages purchased in one establishment CANNOT be taken into any other establishments.

To report a non-emergency concern, call Kent County Sheriff dispatch/non-emergency (616) 632-6100, Press 1. To report an emergency, call 911.

FREQUENTLY ASKED QUESTIONS

What types of alcoholic beverage can I purchase to carry around the designated Commons Area?

Beer, wine, and liquor are all allowable drinks when purchased from a participating licensed establishment and served in a designated container.

Can I just bring my own alcoholic beverages to be consumed in the Commons Area?

No! Drinks must be purchased from a participating licensed establishment. No cans, glass bottles, or outside drinks are permitted within the boundaries per State and local law.

Can I walk anywhere with my drink?

No. Patrons must stay within the designated Commons Area boundaries. Leaving a Commons Area with an alcoholic beverage violates State and local law.

Can I take my beverage into other businesses?

No. Once a designated beverage has left the business where it was served, it must be consumed before you enter any other establishment or patio area.

Can I take an empty designated Social District container into a business so I can reuse it?

No. Social District containers are one-time use. No refills are allowed. You must discard your container after each use.

Can I take my beverage into Legacy Park?

Yes. Legacy Park is part of the designated Commons Area where alcohol can be consumed during Social District hours of operation. Alcohol consumption outside of these hours is prohibited. We encourage patrons to buy food and beverages from participating establishments to enjoy during the concerts in the park.

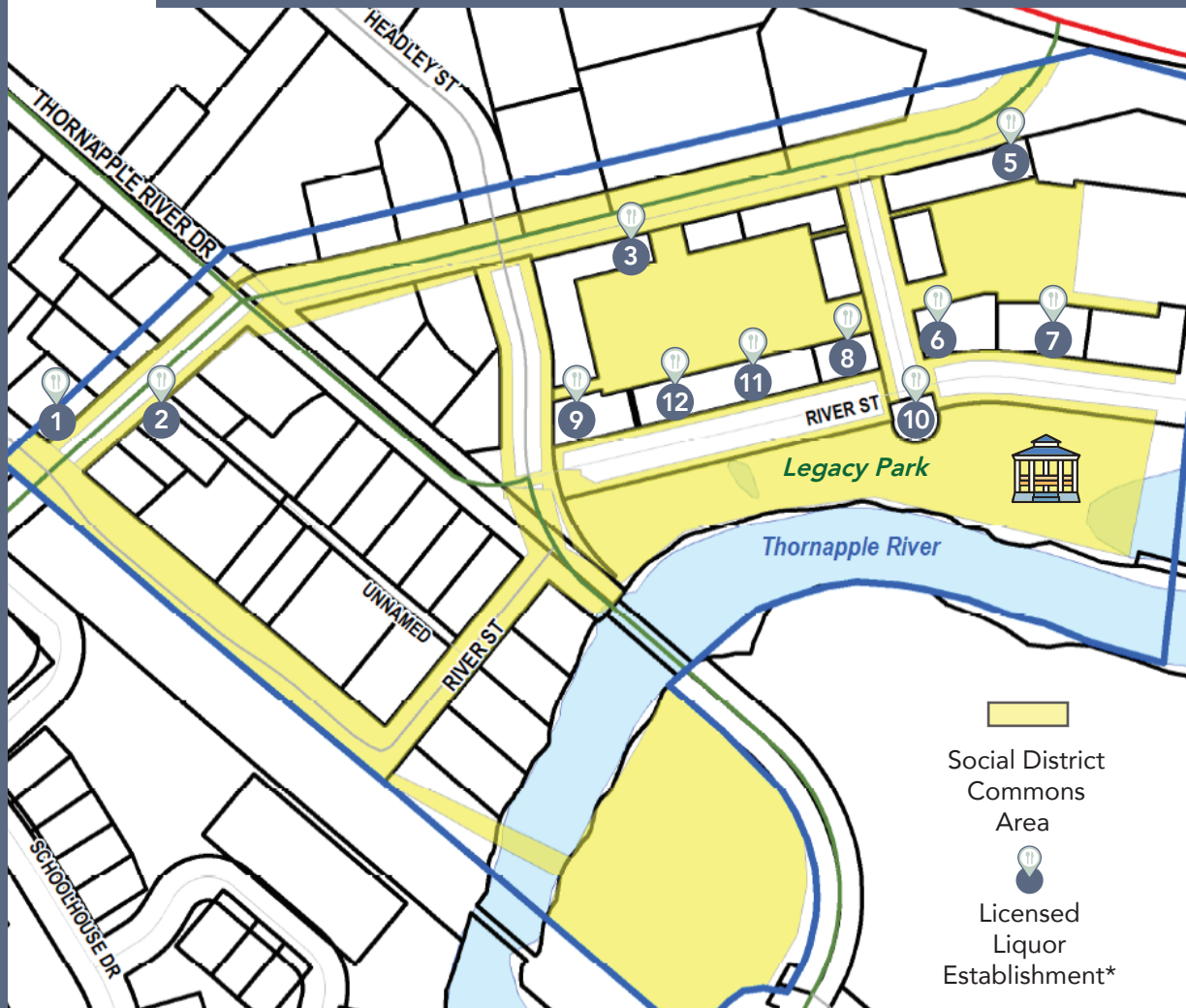
As part of the Ada Village Social District, patrons ages 21+ can purchase an alcoholic beverage from a participating establishment and consume it outdoors within the Social District Commons Area.


Guidelines:

- Only alcoholic beverages purchased from the licensed premises of a Social District permit holder may be consumed in the designated Commons Area. No outside alcohol allowed!
- Alcoholic beverages consumed in the Commons Area are required to be in designated cups from a Social District permit holder. Glass cups and cups larger than 16 ounces are not allowed.
- Leaving the Social District with an alcoholic beverage is not allowed.
- Alcoholic beverages may not be purchased in one licensed establishment and consumed in another.
- Always remember to leave a place a little better than you found it.
