

AMY VAN ANDEL LIBRARY - ADA COMMUNITY CENTER BEGINS TO OPEN

On February 5, the Amy Van Andel Library – Ada Community Center opened its doors to begin limited public access. This long-awaited community treasure is the result of the Township's Envision Ada Plan, with five years of tremendous community input, dedicated volunteer leaders and the generosity of hundreds of local donors. The complete public opening and formal dedication of the building is scheduled for later this spring.



Operations

The Amy Van Andel Library is operated by Kent District Library (KDL). Current library services include online holds, curbside pickup and 30 percent public capacity access to the collection areas within the building. Be sure to refer to the KDL website <u>kdl.org</u> for the latest access information as the facility continues to adhere to all COVID-19 guidelines. The Ada Community Center is operated by Ada Township. Information about Community Center room use will be on the Ada Township website later this spring.

The First Few Details

Located at 7215 Headley Street SE, the two-story, 25,786 sq. ft. building is visible from E. Fulton Street. It sits just west of Ada Drive in the Village of Ada. The building was designed by the architecture team of Progressive AE of Grand Rapids and built by Ada-based Erhardt Construction.

Outdoor Area

As you pull up, you are welcomed by the United States, State of Michigan and Ada Township flags, flying prominently and illuminated at night. The building is lined with expansive windows, letting in an abundance of natural light and providing outward views of downtown Ada and a Central Courtyard. The exterior features three earth tone shades of brick, complimented by aluminum accent panels that coordinate with the window trim. Shaded tables and benches line the walkway, and there are both a walk-up and drive-up book drop. Onsite parking is available, as well as nearby street parking.

The entire building and outdoor grounds feature complimentary Wi-Fi access for guests. Wi-Fi is available seven days a week from 7 a.m. – 11 p.m. All the more reason to grab a coffee and enjoy a seat outside!

Here is a first look at what's inside, with many more details to experience as the building opens fully in the spring.

Ground Level

The entryway foyer will offer residents community resources, a library calendar of events, tax forms, etc. As you pass through the foyer, you immediately experience the view of the Central Courtyard. It's a brilliant outdoor quiet space, surrounded by glass windows on both floors, complete with outdoor seating and tables.

The lobby features a concierge desk and self-check kiosk, along with a book hold area and book return. This area also includes a pop-up corner for Friends of the Amy Van Andel Library and other community activities.

The lobby leads to a spacious work/study lounge with seating and tables, and a dramatic open staircase and elevator provide access to the second floor. The interior space is bright and inviting, with streamlined décor, contemporary fixtures and thoughtful design touches. A separate "pre-function" lobby provides additional space for gatherings and small events. The most prominent experience on the first floor is dedicated to children. More than 7,000 colorful books and media line the shelves at eye level, ready to captivate young readers. And opening soon will be an interactive play space, intentionally designed to promote early learning skills and encourage a lifetime of learning through discovery and exploration. This area also includes a family study room and an adjoining program room.

Upper Level

On the upper level, the staircase and elevator open to a second work/study lounge that offers a variety of openconcept seating options with tables, as well as more private nooks. The tall ceilings and natural light make this an ideal space to work, study or read.

The adult section features a living room with comfortable furniture, anchored by a striking stone fireplace, and the adjacent teen section provides a welcoming environment with low-slung couches and chairs. Rows of books and media across all genres line the shelves in both sections.

Multiple public computers are staged in a central area and there are six private study rooms. Additionally, a soundproof, state-of-the-art podcast studio will allow for livestreaming and recording of KDL and community podcasts and much more. Reservations can be made at the concierge desk.

An enclosed tutoring center offers a conference room setting to fit a larger group and three smaller rooms. Each space is equipped with a whiteboard to encourage brainstorming and collaboration, and the tables are outfitted with easy access to technology charging.

The second floor also houses the two Ada Township community rooms for small and large gatherings. These spacious rooms have floor-to-ceiling windows with retractable shades and the latest in AV technology, and will allow for a variety of seating configurations. Further information as to booking these rooms for family, business or organizational use will be available later this spring.

Residents who do not have a KDL library card can register at the library or online through the KDL website <u>kdl.org</u>.

ADA FIRE DEPARTMENT NEWS –

GARAGE SMOKE DETECTORS?

If you have never thought of it, you are not alone. Smoke detectors are required on all levels of your home and in each bedroom, but not the garage. This past year we had three garage fires, two did extensive damage to the homes while a third was extinguished by the homeowner prior to our arrival. What made the difference? The third home had a smoke detector in the garage. Honestly, until this year I never thought about this. It makes sense though. With so many flammable items in a garage—vehicles, trash cans, gas cans, mowers—the potential for fire is there. I would suggest if you add garage smoke detectors, you install the type that would be wired with your current detectors so all would alert regardless of the fire's location. If you have questions about this or any smoke or carbon monoxide detectors, give the fire department a call.

ADAPTING TO COVID-19

This has been a challenging year for everyone, including the fire department and our response to incidents. You may have seen our team around town now wearing masks when more than one responder is in the vehicle. That is one step we have taken to prevent the spread



of the virus. On an airborne precaution medical response, we also include goggles and gowns, which are cleaned or replaced after the incident. Fortunately, we have had a very limited response to these types of incidents. We have learned to adapt and that includes our trainings. We have set up a second training room to assure classroom sizes of less than 10 members while still maintaining social distancing. The second classroom is actually an apparatus bay with video equipment for a virtual training while live training is conducted in another classroom. For less than \$200 we were able to set up a projector and screen to assure safe training for our team.

BURN PERMITS

With springtime nearly upon us so is the opportunity to clean up the yard from downed branches and twigs. If you plan to burn your yard waste, remember a burn permit is required. To obtain one is a simple phone call to the Township office (616) 676-9191. Here are the guidelines: fires must be out by dark, means of extinguishment present, 50 feet from structures, and someone in attendance at all times.

Open burning is permitted throughout the Township until April 30th. From April 30 – November 1, burning is not permitted in the restricted area. (Restricted area is south of Fulton and west of the Grand River.)

2020 INCIDENT RESPONSE

Our year finished with fewer responses than 2019, which was our highest ever at 755. The increased activity for 2019 included two ice storms and the high winds event. In two days, we responded to over 40 incidents for the February 2019 storm. During the ice storms, we had as many as 7 units on the road at once responding to trees and wires down in all areas of the Township. Below is a summary of our 2020 incidents by type. ADDRESS SIGNAGE

House numbers are required at or near the front door and must be a contrasting color from the home. Homes more than 90 feet from the road or not visible from the road require a sign at the roadway visible from both



directions. On private drives, help us out and clearly mark your driveway from the private drive. Do you have questions about your home and our ability to locate it? Call us! We would be more than happy to answer questions or make a visit to assist you. The reflective green and white address signs you see around town are available from the fire department, and made while you wait. For more information, contact the Fire Station at (616) 676-2376.

CEMETERIES

Ada Township has two cemeteries – Ada Cemetery on Fulton Street and Findlay Cemetery on Two Mile Road. Burial and crematorium spaces are available for purchase by Ada Township residents only. Ada Cemetery is always open. Findlay Cemetery is open on Wednesdays and Fridays through Sundays, beginning April 1. When Spring weather improves, Township staff will be cleaning up winter debris and leftover gravesite materials. If you have items on your family's gravesite(s), please remove by April 1.

ADA/CASCADE RESIDENTS

Did you know??

Permits are required for the installation of replacement *furnaces* and *water heaters*.

We have trained staff to inspect your new replacement furnace and water heater. An inspection ensures that the new equipment is safe and in compliance with the 2015 Michigan Residential Code.

Before signing a contract to have these items replaced, make sure that the contractor will obtain the necessary permits and coordinate inspection upon completion of the work.

Inspections cover important safety items like gas piping, venting and combustion air requirements.

LEAF PICK-UP DAYS

Two curbside, leaf bag pick-up dates will be available for Ada Residents. You will need to purchase bags ahead of time and use them for your leaves. Ada Township no longer sells leaf bags, but they can be purchased at many retail stores; however, they <u>must</u> be leaf or lawn waste bags. Leaves and other compostable yard waste will be all that is allowed in the bags. Have your bags out next to the road at your residence on the following dates.
