

FROM THE SUPERVISOR'S DESK ... A Year In Review



It was around a year ago, November 2020, that I was elected as your Township Supervisor. One interesting aspect of the Supervisor's office is the broad view it offers of the many activities taking place in the Township. A full report would take pages, but in the next few paragraphs I would like to pass on some of the highlights of the last year.

Any review of the last year begins with a deep acknowledgement of the physical loss and emotional toll of the pandemic.

At the same time, the resilience and adaptability of the Ada community has been encouraging. The Township government moved quickly to a virtual format, and in that format continued to operate all of its boards, commissions, and committees, along with providing Township services. In the first half of the last year the Township streamlined its committee structure, adopted a balanced budget, refinanced expensive bonds saving hundreds of thousands of dollars, completed and opened a library, and partnered with Kent County to dramatically increase the size of Chief Hazy Cloud Park on the Grand River.

As soon as the state began lifting gathering restrictions, the Township again moved quickly to plan and hold a 4th of July parade and festivities. The community responded with record attendance. In partnership with the Historical Society the Township held popular live Wednesday night music events at the pavilion in Legacy Park. Softball leagues, pickleball, park programs, and rental of Township facilities flourished. This year the Township also invested millions in water and sewer infrastructure improvements, and it began construction of and worked on further planning of the new and improved Township trail system. The Township DDA sponsored a family friendly "Beers at the Bridge" event with live music that was attended by thousands of residents. New stores, offices, and restaurants were approved by the Planning Commission, and construction of unique new buildings in the village area and new quality homes throughout the Township was strong.

The village area of Ada Township increased in popularity as a place for families and friends to walk, bike, eat, drink and gather together. At the same time the Township took a balanced approach and invested in parks, trails and open spaces outside of the village area. An environmental highlight was groups of volunteers who held events to clean up the river and battle invasive species.

This year the Township hired a new DDA Director, Haley Stichman, and a new Planning Director, John Said. Together with Township Manager Julius Suchy, Fire Chief Dave Murray, Parks Director Mark Fitzpatrick, Assessor Stephanie Boerman and a quality staff, the Township government is operating effectively and efficiently. Many thanks to the resident members of the Planning Commission, ZBA, DDA, DDA Citizens Council, Trail Committee, PLRP, and other Township committees and related associations such as the Historical Society, Friends of the Library, and Ada Business Association for their work this year. And last but not least thank you to the elected members of the Township Board for their work this year. All of these groups are talented, hardworking, and dedicated to serving the public.

On behalf of the Township Board I am pleased to report to you that Ada Township is bursting with energy and excitement for the new year. We are thankful for each one of you, and wish you a prosperous and peaceful new year. GENERATORS & CARBON MONOXIDE

OPEN BURNING



Beginning November 1st – April 30th open burning is permitted in the restricted area. The restricted area is South of Fulton & West of the Grand River. Open burning is for brush and yard waste only; building materials and trash are not permitted. Fire must be attended, have a source of extinguishing the fire, and be out by dark. Remember to get a burn permit by calling

the Township offices, (616) 676-9191, Ext. 29. Recreational fires are allowed throughout the Township year-round without a permit.

WINTER DRIVING

Winter is on the way which means your firefighters will be responding to accidents and slide offs. When you see us on an accident please **SLOW DOWN AND MOVE OVER**, give our team the room to work safely. If you see a car off the road and marked with yellow caution tape, know that the vehicle has been reported and is awaiting a wrecker. Dispatchers are aware of the vehicle, so there's no need to report it again. Thanks for keeping us safe on the roadways!



Gypsy Moth Update and Egg Mass Survey

Ada Township has engaged the services of Aquatic Consulting Services to complete an Egg Mass Survey. Gypsy moth egg masses are the best indicator of population size and health for the coming season. The adult female gypsy moth lays the egg mass soon after emerging from the pupae in late July or August. She then dies without feeding and the eggs stay on the tree until hatching the next spring. When new, the egg masses are generally a rich tan or brown color with a smooth exterior. As they age over winter, they become bleached to a light tan and the exterior becomes eroded and weathered.



If we know the density of the egg masses, their average size, and the amount of parasitism on the eggs, Aquatic Consulting Services can predict with a high degree of accuracy

what the coming summer's population will likely be in that area. Once Aquatic Consulting Services has reviewed the data, they will recommend potential spray locations. The Township will work with identified property owners to discuss any potential spraying plan in 2022. Please contact Ada Township Manager Julius Suchy, jsuchy@adatownshipmi.com with the address of known locations of Gypsy Moth egg mass and/or tree defoliation. Those locations will be passed along to Aquatic Consulting Services. A big thanks to residents who have already contacted the Township with their address for known locations of Gypsy Moths.

For recognizing the Gypsy Moths, the adult females generally have white wings with wavy black markings, while the adult males will be smaller with brown wings with dark markings. The caterpillars with be hairy, with a black and yellow head and 5 pairs of blue spots followed by 6 pairs of red spots

Gypsy Moth caterpillars will begin to emerge from egg masses around April and then feed on leaves. They often feed on Oak and Aspen, but have been found to be on hundreds of other plant species.

Once the Gypsy Moth caterpillars feed on the trees, they can defoliate trees leaving the trees vulnerable to diseases and other pests. This could lead to tree mortality.

Please Keep Working to Reduce Oriental Bittersweet Vines

Winter is still a good time to help eradicate Oriental Bittersweet vines. **Oriental Bittersweet** (*Celastrus orbiculata*) is recognized by long vines that "wind" up trees and their showy red and yellow fruits. As the vines make their way up trees, they



restrict sap flow, cover the tree leaves and eventually kill the tree. Use loppers or pruners to cut the vines at the ground level and as high as you can reach.

It is best to apply an herbicide to the cut section near the ground to prevent new growth. Please be cautious not to get any herbicide on you, nearby plants, or the ground. Woody sections of cut vines can be left to decompose, but any berries should be bagged and put in the trash.

"Christmas Tree Recycling" will take place at Ada Township Park from December 26, 2021 through January 11, 2022. Ada Township residents may drop off Christmas Trees for recycling to the back parking lot of Ada Township Park between 7:30 a.m. and 8:00 p.m.

The trees will be recycled into wood chips. Please remove any decorations, wires, strings, ribbons or other items from the trees that might interfere with a chipper. No wreaths will be accepted this year.

Residential Christmas trees only – no yard waste, trimmings, wreaths or commercial businesses drop off.

PERSONAL PROPERTY

Personal Property is defined by the State Tax Commission as all property that is not real property. So, these are items like furniture and fixtures, machinery and equipment, and computer equipment. Situs is the location of the Personal Property on Tax Day, which is December 31st of every year.

Annually it is the responsibility of the business owner to file a Personal Property Statement reporting the costs of the current assets. There are different types of forms depending on the type of business:

- ♦ Some businesses file the L-4175 which is the Full Personal Property Statement. This form must be completed and delivered to the Assessor's office by Tuesday, February 22, 2022.
- Some businesses may be eligible for the Small Business Property Tax Exemption Form 5076, if they have less than \$80,000 in assets. This form is also due on February 22, 2022 (if not previously exempted in prior years) however postmarks are acceptable.
- Manufacturing businesses may also qualify for the Eligible Manufacturing Personal Property Tax Exemption Form 5278. This form must be completed and delivered to the Assessor's office by Tuesday, February 22, 2022.

The Assessor's job is to complete a Personal Property Canvas at the end of every year to visit new businesses, note changes on existing businesses, deliver forms and answer any Personal Property related questions. All Personal Property parcels are required to have an assessment whether a form is completed and returned or not, so sometimes the Assessor is required to make an estimated assessment.
