# SUPERVISOR'S UPDATE – 2023 YEAR-END REVIEW

As we approach the end of another year, it is time to update you on some of the major Township highlights from 2023. Although this list does not cover everything, the following are some of the significant points from 2023:

- In partnership with the Ada Business Association, Ada Historical Society, and other Ada businesses, the Township hosted in the village area 12 Wednesday night concerts, three Beers at the Bridge events, a weekly farmer's market, a fall festival, and several other events.
- A new contractor was hired to improve the village flowers and plants in public spaces, and murals were completed on two bridges. Improvements were made to Roselle Park and Leonard Field, and trail construction and maintenance continued throughout the Township.
- The Township Board approved concept plans for the Ada Covered Bridge Park, and the Township continued its acquisition of land on the Thornapple River in the village area related to this project. Initial planning for a Township Hall took place. The Adacroft, Ada Woods, Ada Ridge and Ada Towne watermain project was completed.
- A new Master Plan for land use was adopted, and construction of quality commercial buildings and residential homes continued. The Township took action to clean up certain properties, and it actively battled invasive species and gypsy moths.
- Our long-term Parks Director and long-term Deputy Clerk retired. Replacements were hired for the retirements and, for the first time, a Building and Grounds Director was hired. All these new hires are well qualified for their positions.
- The new fire truck arrived, additional equipment to support
  the fire department was purchased, additional firefighters
  were hired, and the fire department received several awards
  for its conduct in handling emergency situations. A second
  community officer from the Kent County Sheriff's Department
  was hired. We survived a tornado and several severe storms.
- The Township's budget was balanced, property values increased, and all of the Township committees, commissions, staff, and boards worked hard and seemed to enjoy what they were doing.

It is our goal at Ada Township to serve you efficiently, fully, and with a smile. Once again, we are thankful for the blessings on Ada in 2023, and we wish you a prosperous and peaceful 2024.



## CARBON MONOXIDE DETECTORS

As we begin to close up our homes for the colder weather, make sure your carbon monoxide detector (CO) is installed; this may require changing the battery. CO is an odorless gas that can be deadly if not detected; the gas comes from defective furnaces, water heaters and appliances. During our recent storms in August, several homes were out of power and relying on generators. We responded to several incidents where CO was detected in homes, all of which were caused by the generators. Because of the warm weather, windows were open and allowed fumes from the generators into the homes at dangerous levels. If you have questions about CO detectors, please call the fire station.

### SMOKE DETECTORS AVAILABLE

It is recommended that smoke detectors be replaced every ten years. Homes built after 1973 are required to have all detectors wired together; this alerts occupants to a fire anywhere in the home by sounding all the alarms. If your home was built prior to 1973, only the area nearest the fire will sound. To ensure that your pre-1973 home is fully protected, we have a supply of smoke detectors on-hand and will come and install them for free. Supplies are limited so call today to receive your free detectors along with an install by the Ada Firefighters.

## **EMT TRAINING**

Our firefighters have completed their Emergency Medical Technician training with a 100% pass rate. Our next step is to outfit our apparatus with the advanced equipment. Once this is completed, state officials will inspect each vehicle for



compliance and they will all be licensed at the EMT level. This process is expected to be completed by the end of the year. After that time, our firefighters will be responding with the most advanced skills and equipment to the next medical emergency or vehicle accident.

### FIRE ACADEMY BEGINS

We have asked for more paid-on-call firefighters and the community has answered. We have five new members who will be attending the Fire Academy from October to March. This is the hands-on and classroom training with which members will acquire the Firefighter II status. Good luck to our new members and thank you for your commitment to your community.



# KENT COUNTY SHERIFF DEPARTMENT -**COMMUNITY UPDATE**

Our communities throughout Kent County have experienced an increase in vehicle larcenies within recent years. Although the Sheriff's Department has been proactive in its efforts to catch offenders and monitor frequently target businesses or neighborhoods, we wish to empower our communities with practical measures they can take to avoid being victim to a vehicle larceny.

### Parking:

Choosing the appropriate parking spot may alleviate being an easy target for vehicle theft. When possible, park in well-lit, busy areas, as thieves are less likely to target vehicles in such locations. Additionally, opt for spots with good visibility, allowing pedestrians and other motorists to observe your vehicle.

## Locking & Securing Your Vehicle:

Always lock your vehicle, even if you are stepping away for a moment. Make sure all windows are closed and double-check that the trunk and sunroof are securely

shut. Most thieves seek out unlocked vehicles and wish to avoid the potential noise and attention which arises from breaking out windows.

# Concealing Valuables:

Visible belongings are tempting to opportunistic thieves. When leaving your car unattended, hide valuable items out of sight, preferably in the trunk or glove compartment. If you must keep valuables inside the car, consider using a car organizer or covering them with a blanket to be less conspicuous.

### Situational Awareness:

Stay vigilant and aware of your surroundings, especially when approaching or leaving your vehicle. Trust your instincts and make note of anything out of the ordinary during your commute to and from your residence. If you notice any suspicious activity or individuals nearby, particularly within your neighborhood, do not hesitate to contact authorities.

### **Community Involvement:**

Encouraging a sense of community can significantly reduce the risk of break-ins. Monitor security and/or ring doorbell camera footage and discuss strange occurrences with your neighbors. Join or establish neighborhood watch programs or a Facebook or Nextdoor App neighborhood group to be notified of any suspicious activity or vehicle theft. Communicate any suspicious incidents to local law enforcement. By working together, you can create a safer environment for everyone.

If you wish to monitor vehicle theft occurrences in real time, the Kent County Sheriff's Office has created a Crime Clearance Dashboard which is updated weekly. As of October 23, there have been 21 reported vehicle break-ins in the township since 2018.

We are eager to engage with our community to answer any questions, discuss concerns, offer training and participate in your events. We provide coverage within the East Precinct five days a week and look forward to serving you.

# FROM THE CLERK'S OFFICE

### **ELECTION NEWS**

There are many election law changes going into effect for the new year.

We expect to have at least three elections in 2024: February presidential primary, August primary, and November general election.

The state will require nine days of early

voting for each election in addition to the usual option of voting absentee. And, of course, you may always vote in person at your precinct.

Ada currently has eight precincts but is looking to consolidate into five precincts. Some precincts will be combining, and some will be changing polling locations. Voters will be receiving new voter identification cards which will show the existing or new precinct and new polling locations for those that change.

We will keep three polling locations, but they will be different. St. Roberts will no longer be available for voting, and we are currently looking for a new location. Again, if your location changes you will receive a new voter identification card in the mail.

For the presidential primary in February, you will only be able to vote in one party. (If you vote in both, your ballot will be rejected and your vote(s) will not count.) The August and November will be general elections and, as normal, you may vote any way you like as long as you don't vote for more positions than are available.

Please do not listen to everything you hear in the media. If you have a question, you may contact township hall, and we will answer any questions you may have.

## **DEVELOPMENT UPDATE - OCTOBER 2023**

The following updates are provided concerning new development projects happening in the Township. (Note: The Township does not have contact information for potential lease/purchase of these projects.)



## "Oxbow" Residential; Fase Street/Thornapple River Drive

New mixed-residential development with 88 condominium dwelling units, including single-family homes, townhomes/duplexes, and multi-family. Utility installation work now underway; completion date not known.

### **Fase Street Crossings**

New 16-home single-family residential development. Now under construction; completion date not known.



### **Fase Street Residential**

Seven new dwelling units; three two-family dwellings and one single-family dwelling. Now under construction; completion date not known.



### Ada Hotel; 7415 River Street

New 29-room hotel with restaurants. Now under construction; tentative opening in Spring/Summer 2024.



### Fulton Street; Village East

New rental residential; 92 units in four buildings (two 3-story, two 4-story). Two buildings (7550 and 7558) now complete and occupied; remaining two buildings (7566 and 7574) are anticipated to be complete by end of 2023.



### 7500 Fulton Street

New 3-story office building with +/- 19,500 square feet. Under construction; completion date not known.

# Commercial-Office Building; 7399 River Street


New 3-story building with first floor commercial/retail space and upper-floor office space. Now under construction; completion anticipated in 2024.

# **WINTER TRAILS UPDATE -**

Below is a short update on some of the trail projects that were approved for this year. If you are interested in seeing a more extensive update, please visit our website as noted at the end of this article.

- Fulton St. (Ada Drive to Grand River and under Fulton to access North side of Fulton St. trail) This project was originally scheduled to be completed by November 7th, but the contractor received an extension to November 30th from the Township Board. The delay was related to blocks for the retaining wall. The contractor has assured the Township that the project should be completed prior to that November 30th deadline.
- Pettis Avenue Phase II (Chief Hazy Cloud Entrance to Vergennes St.) At the October 23rd Township Board meeting the board authorized submittal of a grant request from the Devos Family Foundation for partial funding of a pedestrian bridge over the Grand River from the Chief Hazy Cloud Park entrance to Amway property, ultimately connecting to the Fulton St. trail. If the Township is not successful with this request, then it will need to re-evaluate other options for this section.
- System-wide Trail Repairs The Township completed \$354,199.74 of trail repairs this summer/fall. Moving forward the Township will have an annual repair package bid out to make sure the trail system is in the best shape possible. A map of the trail repairs can be found on our website.
- Wayfinding Signage Corbin Design out of Traverse City presented a wayfinding trail plan to the Township Board and the Board accepted the plan. Now staff will bid out the work and plan to have the signage installed in spring of 2024.

• Thornapple River Pedestrian Bridge – The Township received notice that it was awarded a grant of \$425,000 (or 28%) of the total project cost for the pedestrian bridge over the Thornapple River north of Thornapple River Drive (see rendering below). The remaining funding will come from the Trails millage and a private fundraising campaign.

# TREASURER DEPARTMENT

### BY THE NUMBERS...

As we closed out our summer tax collection season (September 14, 2023), I made a few observations in regard to how residents pay their taxes, most notably, the many of you who pay your taxes in person. We have certainly returned to our pre-COVID levels.

It was therefore no coincidence that with the increase in foot traffic, there would also be an increase in the use of cash. As I examined the data, I saw an increase in cash payments by 27%. Although that percentage increase may seem significant, it



only represents a little over 0.2 percent of our total receipts, as the graph below denotes. This graph also shows the steady increase in payments with a credit card since 2019.

Although credit card payments represent a relatively small percentage of our overall receipts, it does serve as a reminder that this option remains important to you. Having averaged 5,072 transactions during the summer tax collection season, we will continue to explore options that provide the most convenient and cost-effective way to accept and process your credit card transaction. If you are not familiar with the many ways we accept payment, we invite you to reach out to us!

In the meantime, given the trends outlined, it appears there is a good chance we will see some of you this winter.

# ORIENTAL BITTERSWEET - FALL AND WINTER IS THE TIME FOR ACTION

Oriental Bittersweet (Celastrus orbiculata) has become one of the most aggressive invasive plants in our community. It is literally killing trees and reducing our property value and safety. The vines and leaves can be seen along many roadsides and in woodlots throughout Ada Township.

Oriental Bittersweet is recognized by long woody vines that "wind" up trees and showy red and yellow fruits. As the vines make their way up a tree, they constrict the tree trunk and branches restricting sap flow, cover the tree leaves with their own leaves, and eventually kill the tree.

Like the native species, American Bittersweet (Celastrus scandens). Oriental Bittersweet is far more aggressive and common. It is easiest to tell the difference by the way the berries are arranged on

the twigs: American Bittersweet berries are clustered at the end of the twig versus spread-out along it. They can easily be confused in holiday decorations which may add to the spread of the seeds throughout the region.


Removal takes some care and planning. Be careful not to pull down on vines that may cause overhead branches to fall. Note that cutting the vines or young shoots on the ground may stimulate more young shoots to sprout up and then need follow







up work. Similar to other woody invasive plants, like Autumn Olive and Common Buckthorn, removal is recommended late summer through the winter so any herbicide




applications can get into the roots. If you wish to avoid use of herbicides, you will need to revisit the site to pull out small new vines that will start to grow in the area. Use loppers or pruners to cut the vines at the ground level and as high as you can reach. It is best to apply an herbicide to the cut section (stump) near the ground, being cautious not to get any on you, pets, wildlife, nearby plants, or the ground. Woody sections of cut vines can be left to decompose, but any berries should be bagged and put in the trash.

#### "POODLE CUT" METHOD FOR ORIENTAL BITTERSWEET VINE




### CHRISTMAS TREE RECYCLING AT ADA PARK
