### BOARD COMMENT

Trustee Jacobs stated that the Grand Rapids East Rotary had announced its annual Dedication to Vocations award to Supervisor Haga and presented the award to Supervisor Haga.

Clerk Smith stated she received the Certificate of Determination from the Kent County Board of canvassers, which stated gave final results of the township offices. She also stated she was waiting to hear if there will be a state-wide recount in the Presidential vote. If there is a recount, Kent County will have to count by hand 313,000 ballots.

Proos stated he heard about the Declaration regarding the recount, and wondered if Clerk Smith had heard the numbers. Smith stated they certified the election. She didn't know exact numbers, but that Trump defeated Hillary by 10,700 votes in Michigan.

Treasurer Moran acknowledged outgoing Treasurer Rhoades' service to the Township, and thanked him for his assistance with the transition. Tax bills will be going out in the next couple of days.

Supervisor Haga thanked the Rotary and Trustee Jacobs for the honor and recognition.

# UNFINISHED BUSINESS

# ORDINANCE O-112816-1, ZONING ORDINANCE AMENDMENT, ARTICLE XXVI, SIGNS

Planning Director Jim Ferro stated the feedback from the Board was taken back to the Planning Commission and Sub-Committee, and refinements were made to address the concerns expressed by the Board. The Planning Commission unanimously recommended a revised set of amendments at the November meeting. This is more responsive to new circumstances and site context situations that have resulted from the re-development activity in the village, and the new street construction. Most of the revisions concern the C-1 Village District; a couple of the revisions do have general applicability in the other commercial and industrial districts.

Amendments include:

- change the definition of the term "business center", to state "must have a unified or consistent architectural style, character and appearance".
- definition of the term "sign", remove "in view of the general public".
- definition of the term "projecting sign", changed to give more detail regarding orientation of the sign to the building wall, now "identification sign".
- provisions regulating placement of wall signs in the C-1 Village Business District, changed to allow placement of wall signs on the ends of gable-roofed buildings.
- provisions concerning permitted number and size of wall signs in the C-1 Village Business District, changed to vary the total aggregate wall sign area on a building and the maximum size of an individual wall sign.

Moved by Proos, supported by Jacobs, to adopt Ordinance No. O-112816-1, Zoning Ordinance Amendment, Article XXVI, Signs. Roll Call: Yes – LeBlanc, Hurwitz, Jacobs, Proos, Moran, Smith, Haga; No – 0; Absent – 0. Ordinance adopted.
