1.	The undersigned applicant hereby requests a sign permit for the following types of sign(s) (check all that apply):

- a. Individual business freestanding sign: The sign area proposed is \_\_\_\_\_ sq. ft. (maximum 16 sq. ft.), or
  - b. **Business center freestanding sign**: (A "business center" is "two or more uses, activities, or enterprises having one or more of the following characteristics: **1**. They are located in the same building; or **2**. They are located in multiple buildings on one lot; or **3**. They are located in multiple buildings on multiple lots, have shared parking and driveway access to a public street, and the buildings have a unified or consistent architectural style, character and appearance.")

In the event that any two or more uses fall within more than one of the above categories, for purposes of determining the maximum number and size of freestanding signs, the uses shall be considered as being within a business center comprised of the largest grouping of businesses resulting from any of the characteristics identified above.

#### Freestanding signs have the following limitations:

- 1. On a lot or parcel having frontage on and vehicular access from one street or on a corner lot, one freestanding sign is permitted.
- 2. On a double frontage lot having vehicular access from both streets, two freestanding signs are permitted.

(Note: A projecting sign may not project more than 4 feet from the building wall, nor any closer than 2 feet from the street pavement edge or curb line, and must have a minimum ground clearance of 10 feet, if it projects over a public sidewalk.)

A. The planning commission, in its consideration and approval of a special land use, planned unit development or PVM district development plan application, may authorize maximum permitted area of all wall signs in excess of the limit specified above for buildings over 15,000 square feet in floor area.
