An ideal candidate will not only be an enthusiastic advocate for the local food movement but will also possess the creativity and skill to develop compelling content that engages our community through social media platforms and other marketing channels.

This internship offers an exciting opportunity to work with both the manager of the Ada Farmers Market and the Director of the Ada Township Downtown Development Authority (DDA). The Ada Township DDA is dedicated to supporting the vitality of the downtown district through collaboration with local businesses, public promotion, and community partnerships.



REQUIREMENTS

- Ability to handle a flexible work schedule based on workload.

- Develop and maintain good working relationships with DDA Director, Market Manager, vendors, market goers and community members.
- Promote goodwill by representing Ada township in a professional manner with a cheerful, can-do attitude.
- Help manage and update the Market's social media platforms, including Facebook, Instagram, and TikTok, to reach a wide and diverse audience.
- Use your photography skills to capture visually appealing images of the Market, its vendors, and products.
- Attend weekly Markets to assist with Operational and communication needs.
- Contribute to weekly email or social media communications.
- Provide thorough, thoughtful, and correct information to the public.
- Identify creative methods for promoting the Market to the community.
- Assist with development and coordination of market programming including, but not limited to Kids in the Market.
- Support the downtown community and work on joint projects with community partners
- Create and complete additional tasks as directed by the DDA Director and/or Market Manager.
