**Burn Permits** – You may call the Clerk's office (676-9191) to receive your burn permit. Remember: You may burn in the "restricted area" only between the months of November through April. The "restricted area" is that portion of the Township located south of Fulton (M-21) and west of the Grand River.

# A NOTE FROM THE TREASURER...

Winter tax bills were mailed the week of November 26, 2012. If you have not received it, please call our office to obtain another copy. All tax payments are due in our office by 5:00pm, Tuesday, February 14, 2013. Remember **POSTMARKS ARE NOT ACCEPTED** as date receipted. After March 1, 2013 all unpaid real property taxes will be turned over to the Kent County Treasurers Office for collection.

The usual payment options still apply; by mail, in person, or by credit card (*see the reverse side of your tax bill for instructions*). Credit cards are **NOT** accepted at the Township. Additionally, you may sign up for ACH electronic payments. Forms must be returned 15 days before payment is due. Please contact our office for more information about ACH. If you do your *banking on-line, please allow a minimum of 10 business days* for payment to reach us. As stated we do not accept postmarks or check dates as date received. We are not responsible for the date of delivery by the United States Postal Service.

Dog licenses are available at the Township starting December 1, 2012 through February 28, 2013. The State of Michigan requires all dogs age 4 months and older to be licensed. In order for a 2013 license to be issued, a current rabies certificate, and proof of neuter/spay must be presented. You can receive a copy of these through your veterinarian.

Brr. Winter has arrived. I hope everyone had a great fall. I want to remind everyone that with the cold weather, Michigan roads get dangerous. I have a few tips to help everyone make it through winter;

# • DON'T USE YOUR CELL PHONE WHILE DRIVING.

- Wear your seat belt and double check car seats and boosters.
- Don't leave children responsible for securing themselves in the seat.
- Keep dry cloths in your vehicle.
- Emergency kit, including flashlights, water, blanket, snacks and flares.

# FIELD REVIEW NOTICE

The Assessor is required to appraise, for tax purposes, all real and personal property within the Township. Michigan Statute requires that all property be evaluated annually based on current market conditions. This evaluation requires an inspection of each property in the Township.

This includes measuring all buildings and other property improvements on the property, taking current digital photos of the property, verifying the buildings current physical condition reviewing the amenities present, and interviewing the property owners to determine bedrooms, baths, and type of basement, etc.

The State of Michigan has recommended that 20% of properties in a governmental unit be visited each year to review assessment record accuracy and to ensure that properties are being appraised and assessed at 50% of the market value. In efforts to continually improve our excellent standards, the Assessor's office strives to enhance the annual review process and better meet or exceed the State of Michigan's expectations. The goal is that the Assessing office will review at least 20% a year of the Township, then every single property is visited at least once every 5 years.

If one of the inspectors from the Township arrives wearing a Township issued I.D. badge and carrying a clipboard and digital camera and knocks on your door requesting to review your property, please welcome them. Accurate assessments benefit everyone in the community.

# PLEASE INFORM THE ASSESSOR'S OFFICE OF YOUR MAILING ADDRESS UPDATES

Please contact our office within thirty days after a change of address occurs to update your mailing information. This will help with the delivery of assessment change notices and tax bills. Our office number is (616) 676-9191 ext 26.

# FIELD INSPECTIONS

The assessor's office will be working on all open building permits for the year as well as those permits pulled for new construction since January 1st, 2012. The assessor's office will also continue to be working on neighborhood reviews. We will be in a marked township vehicle and will have identification.

# A REMINDER TO ADA RESIDENTS ABOUT SOLICITATION

Even during the winter months, we may have solicitors knocking on our doors. The Ada Township Board of Trustees created a new "Solicitation Ordinance" just this year with Cascade and Grand Rapids Townships, which is stricter than the previous ordinance. Any person "who violates any of the provisions of this article shall upon conviction be deemed guilty of a criminal misdemeanor...". This new ordinance was created for the protection of the residents of our community. If any of the following infractions are observed, please call the **Kent County Sheriff's Department, East Precinct at: 632-6100, ext. 2**.

A few infractions to look for are:

"...it shall be unlawful for any person to engage in solicitation without having first obtained a permit issued by the township. The permit must be visible at all times while solicitor is engaged in the act of soliciting and shown upon the request of any person."

"While conducting any act of solicitation, the solicitor shall clearly display permit and photo identification that correctly identifies who the solicitor is and for whom the solicitor is working."

"No persons shall travel from door to door, street to street, or place to place within the township while engaged in solicitation except between the following hours:

- (1) April 1 to September 30; 9:00 a.m. to 7:00 p.m.
- (2) October 1 to March 31; 9:00 a.m. to 5:00 p.m.

# ASSESSMENT CHANGE NOTICES

Towards the end of February the assessment change notices will be mailed. Hearings by the Board of Review will be held in March. Sales data and comparative assessment information will be available for your review in the Assessor's Office after the notices have been mailed. <u>Appointments are</u> <u>needed</u> and will be scheduled after the notices are sent. When you receive your Assessment Notice in February, review the information and call with any questions or to schedule an appointment with the Board of Review.

# **DID YOU KNOW?**

- Your taxable value can never exceed your assessed value.
- It is your responsibility as a taxpayer to review your property record card periodically to be sure the information is accurate with all the information that is currently on record.
- The assessor is not permitted by State Law to automatically set your new assessment at one half of your purchase price.
- The assessing staff is available Monday thru Friday from 8:30 a.m. to 5:30 p.m. Feel free to come in or call 676-9191, ext 26 if you have any questions on your property. The assessing system is quite complex, and we are always willing to help our taxpayers understand how the system works.

# HOLIDAY SAFETY TIPS

### **Christmas Trees**

What's a traditional Christmas morning scene without a beautifully decorated tree? If your household includes a natural tree in its festivities, keep the tree watered.Christmas trees account for hundreds of fires annually. Typically, shorts in electrical lights or open flames from candles, lighters or matches start tree fires. Well-watered trees are not a problem but a dry and neglected tree can be.

#### Selecting a Tree for the Holidays

Needles on fresh trees should be green and hard to pull back from the branches, and the needles should not break if the tree has been freshly cut. The trunk should be sticky to the touch. Old trees can be identified by bouncing the tree trunk on the ground. If many needles fall off, the tree has been cut too long and, has probably dried out, and is a fire hazard.

# Caring for Your Tree

Do not place your tree close to a heat source, including a fireplace or heat vent. The heat will dry out the tree, causing it to be more easily ignited by heat, flame or sparks. Do not put your live tree up too early or leave it up for longer than two weeks. Keep the tree stand filled with water at all times.

### Disposing of Your Tree

Never put tree branches or needles in a fireplace or wood-burning stove. When the tree becomes dry, discard it promptly. The best way to dispose of your tree is by taking it to a cycling center or having it hauled away by a community pick-up service.

### **Holiday Lights**

### Maintain Your Holiday Lights

Inspect holiday lights each year for frayed wires, bare spots, gaps in the insulation, broken or cracked sockets, and excessive kinking or wear before putting them up. Use only lighting listed by an approved testing laboratory.

#### Do Not Overload Electrical Outlets

Do not link more than three light strands, unless the directions indicate it is safe. Don't run extension cord under rugs were they will be walked on.

### **Holiday Decorations**

# Use Only Nonflammable Decorations

All decorations should be nonflammable or flame-retardant and placed away from heat vents. If you are using a metallic or artificial tree. make sure it is flame retardant.

# Never Put Wrapping Paper in the Fireplace

Wrapping paper in the fireplace can result in a very large fire, throwing off dangerous sparks and embers that may result in a chimney fire.

#### **Candle Care**

#### Avoid Using Lit Candles

If you do use lit candles, make sure they are in stable holders and place them where they cannot be easily knocked down. Never leave the house with candles burning. Never Put Lit Candles on a Tree.

#### **Heating Fire Safety**

- <u>Keep Fireplaces and Wood Stoves Clean</u>
  Have your chimney or wood stove inspected and cleaned annually by a certified chimney specialist.
  - Clear the area around the hearth of debris, decorations and flammable materials.
  - Always use a metal mesh screen with fireplaces. Leave glass doors open while burning a fire.
  - Install stovepipe thermometers to help monitor flue temperatures.
  - Keep air inlets on wood stoves open, and never restrict air supply to fireplaces. Otherwise you may cause creosote buildup that could lead to a chimney fire.
  - Use fire-resistant materials on walls around wood stoves.

#### Safely Burn Fuels

- Never use flammable liquids to start a fire.
- Use only seasoned hardwood. Soft, moist wood accelerates creosote buildup.
- Build small fires that burn completely and produce less smoke.
- Never burn cardboard boxes, trash or debris in your fireplace or wood stove.
- When building a fire, place logs at the rear of the fireplace on an adequate supporting grate.
- Never leave a fire in the fireplace unattended. Extinguish the fire before going to bed or leaving the house.
- Soak hot ashes in water and place them in a metal container outside your home.

- <u>Protect the Inside of Your Home</u> Install smoke alarms on every level of your home. Test them monthly and change the batteries at least once a year. Consider installing the new long life smoke alarms.
  - Provide proper venting systems for all heating equipment.
  - Extend all vent pipes at least three feet above the roof.

The National Fire Protection Association and the U.S. Fire Administration estimate 250 home fires involving Christmas trees and another 170 home fires involving holiday lights and other decorative lighting occur each year. Together, these fires resulted in 21 deaths and 43 injuries.
