EAGLE ROOSTING SPOT NOW PERMANENTLY PRESERVED

The bald eagles frequently seen perched in the trees above the confluence of the Grand and Thornapple rivers near the M-21 bridge for the past several winters will now have the assurance their prime fishing spot will not be lost to a bulldozer or ax. The Ada Township Board unanimously approved the purchase of the property for \$10,000 from Bob and Helen Logee (formerly of Ada Township).

The 19-acre wooded site was purchased by the Township with funds from the "Parks and Land Preservation" Millage approved by Township voters in November 2002. Thank you to Bob and Helen Logee for allowing us to acquire and preserve this attractive and highly-visible natural area which abuts with the 2 1/2 acre sight purchased by the township from MDOT a few years ago.

BOYNTON SCHOOL

by David Anderson 391 Boynton

This building is located on the southeastern-most corner of Section 25 in Ada Township as it borders Vergennes Township. This building is one of Ada Township's one-room schoolhouses (District 4 fractional). The term "fractional" was used to note its students came from both Ada and Vergennes townships. Ada had nine schools at the turn of the century.

391 Boynton (Boynton School) is of frame construction with an original size of 24 feet by 36 feet, sitting on a cement block foundation with eight windows and lap wood siding painted white with a wood shake roof. The interior is comprised of 12-foot high ceilings, 1 by 4 –foot window trim, plaster wall sheeting and a maple varied-width tongue and groove wood floor, wood-burning stove, indoor water pump. The location also had a wood shed and two out houses.

The location of the Ada schools is of great interest to history buffs and Ada residents. Documents near the turn of the 1900's showed schools located at numerous sites that are now void of any signs of the schools today. Several sites still have signs of the buildings existence and/or remodeled residences.

These locations are: ADA 1, Ada, Ada Drive (Amway fitness center). ADA 2 River school, northeast corner of Pettis and Egypt Valley (Rieth-Riley office). ADA 3 Carl School, northwest corner of Carl Drive and Grand River, this school was moved to downtown Ada and is now known at the Little Red Schoolhouse. ADA 4 Honey Creek School, located near the entrance to Siedman Park off Conservation, today only the foundation can

be seen. ADA 4 Fractional Boynton School, northwest corner of Vergennes and Boynton, still standing. ADA 6 Fractional Farrell School, northwest corner of McCabe and 2-Mile Road. Only the foundation can be seen today. This school was located on land that was owned by a Mr. Farrell whose family has owned this land since

the original land grants of the

1830's. ADA 8 Fractional Egypt Valley (Chapel), north-west corner of 3-Mile Road and Egypt Valley Road, nothing remains of the school today. ADA 12 Fractional Atwater School shared with Grand Rapids Township, southwest corner of 3-Mile Road and Grand River, this

school is still standing and has been remodeled into a residence.

ADA 13 Chase School on the east side of Honey Creek just south of Knapp Street. It is currently a remodeled residence.

* * *

Anecdotes about old-time school days in the one-room schools are found in oral histories given to the Ada Historical Society. Often the older boys had to miss a lot of school to help harvest the crops.

There would be a woodshed at the school and the school board had the responsibility of keeping it full of wood.

Some recalled 30 to 40 students in their schools, but most remembered small groups of a dozen or so.

From Esther Hazlett, who went to Egypt Valley School, talked about an unpopular teacher. The kids cut the rope on the school bell. The teacher got a ladder from the neighbor just across the road and he went up in the belfry to fix the bell. The kids took the ladder down. "I thought they were going to leave him up there so I ran to the neighbor's to get help to get him down. That teacher didn't last the whole year.

Margaret Farrell Jakeway: "When I was five years old I went to kindergarten for two weeks in the spring time. Then in the fall I started the first grade. The school had all eight grades if there were enough kids but there were never more than ten kids that ever went to that school of all the different grades. I think the grade I was in had the most and there were three of us.

"We had a lot of fun. On the southeast corner of the school yard there was always a pond. Well, the least little bit of ice and we were on that pond. Well, we went over there and we were in the fourth grade and the ice wasn't thick enough to hold our weight and we all went in there and got our socks all wet and of course we all wore long underwear then and we got that all wet. We had to sit around the old stove in the schoolhouse to dry out.

"We would all take our sleds to school. We used to slide down the hill there. Then we used to get pails of water and slick it down, making it really icy to go faster."

Ken Anderson: "I went to school at Chase School through the eighth grade. There were 12 or maybe 14 in all eight grades. In the winter, there was a pond a short distance from the school and we always had an hour for

How do you tell if something could be hazardous? Read the product labels. Words such as "Danger", "Poison", "Warning", or "Caution" will identify products that contain hazardous ingredients. When these products are discarded, they become household hazardous wastes. These products generally fall into five categories:

- · Cleaning Products: Drain openers, oven cleaners, polishes, spot removers.
- · Automotive Products: Gasoline and solvents, brake or transmission fluids, car batteries, polishes and waxes.
- · Paint and Paint Products: Thinners, mineral spirits, oil base paints, stains and varnishes, aerosol cans, epoxies and adhesives.
- · Pesticides: Weed killers, insecticides, fertilizers, wood preservatives, rat or insect poisons.
- · Miscellaneous: Pool chemicals, driveway sealer, roofing tar, hobby or photo chemicals, mercury, batteries (Ni-Cad, lithium, alkaline, etc.).

The Bailey Monster...

As the story goes, through the fog and mist of the marshes in the northern section of Ada, Michigan it is not unlikely to hear a faint scream or moan... some say you will even hear what sounds like a long curdling cry of pain. Over the years various reports from residents, hunters and hikers have stated seeing a large manlike figure at least 6 foot rise from the swamps and bogs along Bailey and McCabe and disappear as quickly as it had appeared.

As the legend tells it sometime in the 19th Century a against the Foreman (whom large burly man with dark eyes and dark hair owned a inherited all the property) farm in the northern section of the township, he could be antagonistic at times and as it is told, he played as hard as he worked.

It was not unlike the Farmer to load up his wagon with his foreman and head south along the rocky road into "town" on Saturday for what



often became a very long night of poker and homemade beer in the modest, but well stocked bar of the Ada Hotel.

The legend states on the night of the full Harvest moon he and his Foreman got home around 3AM after a very long night of poker where the Farmer had lost more then he had in his pocket to the Foreman. When they arrived home the Foreman went to his sleeping quarters attached to the tack room off the main barn and the Farmer fell into his comfortable feather bed instantly falling asleep. The Farmer awoke in a startle by the sound of the front door being kicked in, and before the Farmer could get out of

bed he was staring at the red face of his Foreman demanding the Farmer pay him his winnings from the poker game now!

> The Farmer at first try to explain he would get the money first thing Monday morning when they took the crop to town. The Foreman was in no mood for excuses and continued demanding what was owed him. By this time the Farmer was angry and told the Foreman to leave his home and his property. The

Foreman left... only to return within minutes with his shotgun and large hunting knife. Farmer was never seen again, no body was ever found. Therefore, no charges were ever brought.

No body found, No crime committed?

Five years later on the night of the Harvest Moon the Foreman was found drowned... on the front

porch of what had been the Farmers home prior to his disappearance. The home was 150 yards from the marshes and still the Foreman laid dead with water and debris from the marsh still in his mouth.

This too was strange because everyone knew that ever since the Farmer had disappeared the Foreman refused to approach the marshes during the day much less in the middle of the night.

The Foreman had lost all his money and sold all the livestock that he inherited upon the Farmers disappearance to pay his own poker debts...he was buried in an unmarked paupers grave with no one but the undertaker and his assistant to lay him to rest. However, as the locals tell it, to this day on the night of the full Harvest Moon the Bailey Monster rises from the swampy water only to disappear without a trace.

So now even in death the Farmer's debt is still not paid?
