



## DOWNTOWN DEVELOPMENT AUTHORITY PROGRESSIVE TASTING EVENT PARTICIPATION TERMS AND CONDITIONS

**By purchasing a ticket to participate in the Progressive Tasting Event, the ticket purchaser agrees to the following terms and conditions:**

- 1) The term “DDA” refers to the Ada Township Downtown Development Authority.
- 2) The term “Township” refers to “Ada Township.”
- 3) The terms “Ticket holder” and/or “Participant” refer to a person who has purchased a ticket to participate in the Progressive Tasting Event for the date listed on the ticket.
- 4) The term “Participating Establishment” refers to a licensed local restaurant located in Ada Township that has agreed to participate in the Progressive Tasting Event.
- 5) The term “Ticket” or “Admission Ticket” refers to a ticket purchased from the DDA in exchange for a complementary food item or items at a Participating Establishment.
- 6) The term “Event” means the “Progressive Tasting Event” organized by the DDA, and/or its affiliates, agents, or contractors, for the date specified on the ticket.
- 7) The term “complementary food item” means a food item or items selected, prepared, and provided by the Participating Establishment.
- 8) Purchase of a Ticket is required for participation in the Event.
- 9) All Participants must be 21 years of age or older to participate and must, upon request of a Participating Establishment, present a valid state or federal photo ID clearly displaying the Participant’s date of birth.
- 10) Tickets are valid for the date of the Event only.
- 11) A Ticket entitles a Participant to a complementary food item or items at each of the Participating Establishments on the date of the Event pending availability. Tickets have no other cash value and are not valid for any other use.
- 12) Participating Establishments may, on their own accord, provide a complementary pairing of a beverage with the food item(s).
- 13) The purchase of a Ticket does not entitle a Participant to alcoholic beverages and a Ticket is not valid for the exchange, conveyance, sale, sampling, or consumption of alcohol.
- 14) All photographic depictions of prior events and/or any other marketing or promotional materials are for marketing purposes only and are not intended to represent the DDA’s and/or Ada Township’s offering, conveying, providing, and/or selling of alcohol to Participants.
- 15) By attending the Event, Participants agree and consent that all photos and videos taken by the DDA and/or its contractors at the Event may be used by the DDA for marketing and promotional purposes.
- 16) Tickets are nonrefundable and may not be duplicated.
- 17) By purchasing a Ticket an individual represents and agrees that he/she/they are 21 years of age or older, and that he/she/they agree to hold the Township and the DDA, and their representatives, agents, employees, officials, and insurers harmless for any injury, loss, claim, action, damage, or harm resulting and/or arising from his/her/their participation in the Event.
