#### **APPROVAL OF AGENDA**

Moved by Proos, supported by Westra, to approve the agenda as presented. Motion carried.

# PUBLIC HEARING - BROWNFIELD PLAN FOR BROWNFIELD REDEVELOPMENT ZONE WITHIN THE TOWNSHIP OF ADA

# Moved by Westra, supported by Ensing Millhuff, to proceed into public hearing to discuss the Brownfield Plan redevelopment zone within the township of Ada. Motion carried.

Rick VanDellen, from Alticor, and John Byl with Warner, Norcross & Judd, explained Alticor's opportunity to get a 10-year contract to make cleanser. The plan would involve a \$10 million investment in equipment and the hiring of approximately 26 employees. John Byl added a site remediation had been completed several years ago at a cost of \$8 million. Adoption of the Brownfield Plan would permit Alticor to apply for a State of Michigan business tax credit.

There was no public comment.

Board members had questions/comments about the impact on the township's revenue, potential future employees, Phase I and II reports, contamination clean-up, length of the anticipated contract and the amount of the investment.

Moved by Proos, supported by Westra, to close the public hearing. Motion carried.

## **NEW BUSINESS**

#### **ADOPTION OF BROWNFIELD AUTHORITY BY-LAWS**

Supervisor Haga explained there had not been any activity on the Brownfield from the original appointments and the by-laws had not been adopted.

Planning Director Ferro stated there was correspondence from legal counsel describing the original issue identified when the draft by-laws were reviewed three years ago and the recommended changes. One recommended change was regarding the distinction between officers of the authority and officers of the board and the potential conflict for those officers of both boards who could be put in the position of voting on their own compensation. The second recommended change was regarding indemnification of board members and officers. The draft by-laws had been reviewed and recommended by the Brownfield Authority Board.

Moved by Proos, supported by Sytsma, to approve the adoption of the Ada Township Brownfield Redevelopment Authority by-laws as presented. Motion carried.

#### **ADOPTION OF BROWNFIELD PLAN**

Supervisor Haga noted a correction on Planning Director Ferro's memorandum of February 19, 2008 which stated action was planned for this meeting on the PA198, explaining the action planned for this meeting is a public hearing and adoption of the Brownfield Plan only. Moved by Westra, supported by Pratt, to adopt the Brownfield Plan as recommended by the Brownfield Redevelopment Authority of Ada Township. Motion carried.

# PETITION OF ADA TOWNSHIP TREASURER TO STRIKE PERSONAL PROPERTY FROM TAX ROLLS

Treasurer Pratt explained taxes still on the roll date back to 2002, and the amount applied to Ada Township was \$281.07. Letters had gone out to the various taxing authorities, adding all due diligent had been applied to collect the taxes. **Moved by Proos, supported by Sytsma, to adopt the waiver and consent authorizing the supervisor to acknowledge and strike the personal property from the tax rolls, with the township's amount being \$281.07. Motion carried.** 

# RESOLUTION R-021108-1 - BUDGET AMENDMENT #1 TO 'FY 07/08 BUDGET

Supervisor Haga explained one major adjustment was made to separate the engineers' expenses from the construction expenses, and this resolution would allow internal adjustments to be made.

Moved by Sytsma, supported by Proos, to adopt Resolution R-021108-1, which is Amendment #1 to the budget for fiscal year April 1, 2007 to March 31, 2008.

There was discussion among board members regarding establishing a capital improvement plan, long-term expenditures, establishing a special committee to work on capital improvement and long-term expenditures or referring it to the Administrative Committee and feedback from the charrette process,
