#### RESOLUTION R112612-1, GRAND RAPIDS TRIATHLON 2013 RESOLUTION R-112612-2, MICHIGAN TITANIUM 2013

#### **RESOLUTION R-112612-3, TOWNSHIP ANNUAL MEETING DISCONTINUANCE**

Clerk Burton stated as discussed previously, the Annual Meeting is very poorly attended. She stated originally the Annual Meeting was for the electorate to attend and vote on important issues such as salaries, adding trustee positions to the Board, purchase of property, etc., all of which, by statute, now goes to the Board of Trustees. Burton stated in 1988 a bill was passed that states townships are no longer required by statute to hold Annual Meetings. She stated a resolution is proposed to end regular Annual meetings if that is what the Board votes on, and if in the future the residents of Ada would like the Annual meeting to be reestablished they can do through petitions and reelection.
