#### **NEW BUSINESS**

## FREEDOM OF INFORMATION ACT (FOIA)-PROCEDURES AND GUIDELINES

Supervisor Haga reviewed the summary of changes made by the recent amendments to the Michigan Freedom of Information Act (FOIA), which goes into effect on July 1, 2015.

# Motion by LeBlanc, supported by Rhoades, to approve the Freedom of Information Act (FOIA)-Procedures and Guidelines. Motion carried.

## ENVISION ADA-HEADLEY STREET CONSTRUCTION

Steve Groenenboom, Moore & Bruggink, reviewed a summary of the meetings held in regard to moving Headley Street, which will be relocated 81 feet north, and there will also be a new intersection on Fulton Street. He then went over the changes needed to the village regarding the 100-year flood plain. He stated the schedule is for Amway to take bids on July 2<sup>nd</sup>; July 13<sup>th</sup> is set for Township Board approval; construction should begin around July 15<sup>th</sup>; and the Headley Street realignment project will hopefully be completed and open by November 15<sup>th</sup>. He stated the Planning Commission and DDA approved this Headley Street concept at their May meetings.

Motion by Smith, supported by LeBlanc, to approve the Headley Street Alignment Plan and scope as presented, with the understanding the construction will not commence until the development agreement between the Township and GELD, LLC has been approved and signed by both parties. Motion carried.

Trustee LeBlanc asked if Road Commission approval has been received.

Groenenboom stated they have seen the plans and know everything that is going on. They do not want to grant approval until the development agreement is in place, and a petition has been received from all property owners saying they are in favor of abandoning the Headley Street right-of-way and have signed off on the DEQ permit. Engineer for Progressive AE Mike Oezer updated the Board on the progress of the right-of-way abandonments.

Corky Paul, 89 River Street stated for 10 years Ada has been waiting for this. He thanked everyone for finally reaching the point that this is going to be a reality.

#### CHANGE ORDER #1, CARL CREEK CROSSING PROJECT

Planning Director Jim Ferro stated there are three minor changes to the Carl Creek Crossing public access improvements project that is now under construction, which result in a net deduction of \$2,790.00.

Motion by LeBlanc, supported by Smith, to approve Change Order #1, Carl Creek Crossing Project. Motion carried.
