1. Request for Variance from front yard setbacks in the VR zoning district to allow an addition to be 8 feet, 8 inches from the front property line instead of the required 15 feet, Bernard Veldkamp, 7125 Bronson St., 41-15-33-228-002.

Bernard Veldkamp, 5580 Hall St. representing Conservation Properties. Mr. Veldkamp gave an overview of Conservation Properties and its mission statement. Mr. Veldkamp stated this was the third project they have done in Ada pointing out each one and their locations. Major reconstruction had been taken on all three buildings which are 19th century buildings and were outdated, stripped down to the foundation, replacing all external structural supports. The current property has been rewired, replumbed and replaced all existing windows, doors, heating and water system. Mr. Veldkamp stated Conservation Properties has kept the current residence with the aesthetics of the other homes in the area. A front porch has been built and other improvements were made.

Member Fields thanked the applicant for the thorough presentation.

Chairman Boman stated there were two correspondences from the neighbors stating they were in favor of the request.

Chairman Boman stated it was a very thorough presentation and there was practical difficulty.

Member Lowry stated he was very impressed by the home and it blends in with the rest of the homes.
