1. Request for variance from Private Road Standards to allow a Private Road to serve 4 homes with a 20 foot surface width, and a 30 foot easement width, less than the required 22 feet and 66 feet, Scott Lancaster, 6838 Skyevale Ct., 41-15-21-205-015.

Member Dixon recused himself from the agenda item, stating that he had a conflict of interest.

Scott and Maggie Lancaster, 6838 Skyevale Ct, presented the request to the board. They stated that they own lot 15, which is their residence, vacant lot 13, and have an option on a proposed split to the east.

Scott explained that the potential lot would be the fourth property on the private road, requiring a variance from our width and right of way standards.

There was discussion about widening the road and if the neighbors would agree, Mr. Lancaster said they would rather not widen the road.

- 1. The applicant must receive site plan approval from the Planning Commission for the proposed land division
- 2. Before a building permit is issued on the proposed parcel, the applicant must provide the Ada Township Fire Chief with a site plan showing marker posts as well as a fire truck turn around on the proposed parcel.
